WHEREAS, the parties hereto desire to amend the above Lease to issue Notice To Proceed on the requested change orders in accordance with Exhibit A (14 pages), attached and made part of this lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon execution by the Government as follows:

1. The following changes are made in accordance with the changes clause of the General Clauses of the lease, section 552.270-14(2), Works and Services:

Change Order #02 (dated 10/18/2012) – Furnish and install 1 pair painted hollow metal doors, frames and hardware near the loading dock. Hardware includes [REDACTED]. Price includes required security for the additional doors. Furnish and install 40 additional CAT 6 plenum cable lines to specified location. Add 20 gauge metal strapping behind gypsum board at wall mounted TV areas: **\$14,142.50**

The changes described above and in the attached Exhibit A (14 pages) pursuant to this Lease Amendment shall be maintained by the Lessor during the term of this lease and are to remain the property of the Lessor. Lessor waives restoration of the premises for these changes. The total cost for the above work is **\$14,142.50**. All changes performed under this contract shall not exceed **\$14,142.50**.

Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of **\$14,142.50** upon receipt of an original invoice after completion, inspection, and acceptance of the space by the Contracting Officer.

If the invoice is not submitted on company letterhead, the person(s) with whom the Lease contract is made must sign it.

3. The Lessor hereby waives restoration as a result of all improvements.

4. Use of the GSA Form 276, Supplemental Lease Agreement (SLA) has been discontinued. All references in the lease to "GSA Form 276" or "Supplemental Lease Agreement" shall be now hereby construed to mean "Lease Amendment."

5. All other terms and conditions remain in full force and effect.
