hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease to **issue notice to proceed for the security scope of work and improvements and to provide invoicing instructions for the work to be paid lump sum.**

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective April 3, 2012 as follows:

- A. This SLA serves as Notice to Proceed (NTP) for the Social Security Administration (SSA) Security Scope of Work and Improvements in the amount of \$56,906.33.

The Security Improvements cost of \$56,906.33 shall be paid to the Lessor via a one-time lump sum payment, upon inspection and acceptance of the security work by the Government. The Lessor shall deliver the security work in conjunction with the SSA tenant improvements.

- B. Upon completion of the work, the Lessor shall contact the lease contracting officer for an inspection. After inspection and acceptance of the work by the Government, a properly executed original invoice in the amount of \$56,906.33, shall be forwarded to:


