B. Upon completion, inspection and acceptance of the space, the Government shall reimburse the Lessor, as described in paragraph A above, upon receipt of an original invoice. A copy of the invoice must be sent to the GSA Contracting Officer for review and approval. Upon approval, the Lessor must submit an invoice including the PDN Number (#PS0024090) directly to GSA Finance, Greater Southwest Region (7BC), P.O. Box 17181, Fort Worth, Texas 76102-181. The invoice must reference the Lease, Supplemental Lease Agreement (SLA), PDN Number PS0024090, invoice date, unique invoice number, name of Lessor as shown on the lease, and it must describe the work completed along with the amount billed.			
All other terms and conditions of the lease shall remain in force and effect.
