WHEREAS, the parties hereto desire to amend the above Lease. This SLA is to incorporate change orders 1-5 of the Child Care Renovation Project.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective October 30, 2006, as follows:

- A. Lessor shall furnish all labor, materials, tools, equipment, services and all associated work to perform the scope of work in accordance with attached revised proposal dated October 27, 2006 in the amount of [REDACTED].
- B. Upon inspection and acceptance of said work by the Government, a properly executed invoice shall be forwarded to: General Services Administration, Greater Southwest Region (7BC), P.O. - C. For an invoice to be considered proper, it must:
 - 1) Be received after the execution of this SLA,
 - 2) Reference the Pegasys Document Number (PDN), specified on this form,
 - 3) Include a unique, vendor-supplied invoice number,
 - 4) Indicate the exact payment amount requested, and

All other terms and conditions of the lease shall remain in force and effect.
