WHEREAS, the Government and the Lessor have previously agreed to tenant improvements for this lease and;

WHEREAS, the Government desires to make additions/changes through change orders;

WHEREAS, SLA No. 5 provides approval and the Notice-to-Proceed for Change Order #3, Change Order #5, Change Order #6, and Change Order #8;

WHEREAS, the Government wants to approve change order No. 5 in the amount of \$15,000.31 to be paid in a lumpsum payment to the Lessor upon completion of the work and acceptance of space by the Government.

THEREFORE, the parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended effective on March 19, 2012 as follows:

Supplemental Lease Agreement (SLA) No. 5 to lease GS-05B-18366, is hereby issued to provide NOTICE TO PROCEED for Change Order #3, #5, #6, and #8 as follows:

Change Order #3 – install Interactive Video Training (IVT) System in the amount of [REDACTED] as shown in Exhibit A attached to this SLA No 5. Exhibit A is the Lessor's proposal for the Interactive Video Training (IVT) System for Change Order #3.

Change Order #5 – install Motorola Q-matic Security Systems in the amount of [REDACTED] as shown in Exhibit B attached to this SLA No 5. Exhibit B is the Lessor's proposal for the Motorola Q-matic Security Systems for Change Order #5.

Change Order #6 – install Frosted Glass in rooms 214, 215, 216, 226, and 227 in the amount of [REDACTED] as shown in Exhibit C attached to this SLA No 5. Exhibit C is the Lessor's proposal for the Frosted Glass for Change Order #6.

Change Order #8 – install Manual Roller Shades on windows in the amount of [REDACTED] as shown in Exhibit D attached to this SLA No 5. Exhibit D is the Lessor's proposal for the Manual Roller Shades for Change Order #8.
