WHEREAS, the parties hereto desire to amend the above Lease to establish to establish lump sum payment for design of UPS, generator, and cold aisle containment.


NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, Effective, August 26, 2011, as follows:
