WHEREAS, the parties hereto desire to amend the above Lease. **To provide alterations to the leased premises.**


NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective as follows:

1. The Lessor shall furnish all labor, materials, tools, equipment, services, and associated work to provide, install, complete and maintain said work, as outlined in the attached bids and drawing, by June 9, 2015. The Lessor shall furnish all labor, materials, tools, equipment, services, and associated work to provide, install, complete and maintain said work, outlined in Exhibit "A", by close of business on. The Lessor shall provide the following work: Installation of deck to deck walls around the conference room area, 2. Update minor electrical and data work.
2. Upon completion and the Government's inspection and acceptance of work, the Government shall pay the Lessor a one-time lump sum payment of \$29,486.96.
3. All work for this project shall be performed in accordance with all ABAAS, environmental, construction and safety standards outlined in the lease.
4. All work for this project shall be performed in according to the "General Conditions for Lease Alterations" (Exhibit B), a copy of which is hereby attached and made part of this lease.


