## Description of Amendment/Modification

GSA Leasing Support Services, [REDACTED] Service Area (Zone [REDACTED]) - Modification PS02 incorporates the following changes:

1) Deobligate the total amount of appropriated funds in line item 1. Per section B.3.2 of the contract the government has met the minimum quantity for this zone; therefore no payments will be made under this contract. As a result of this modification the total contract price is decreased by \$ [REDACTED] from \$ [REDACTED] to \$0.

2) Replace Section B-J of the contract in its entirety with the attachment. (The modified areas of the contract have been highlighted or struck through.) Summary of modified sections and description:

- (d) Replace Exhibit 5c - Removed GSA Regional CO and Property Involved and added RLP Solicitation Number at the top of the form. Extended lines for the revised 2 items at the top of the page. In the first paragraph, added the contract number with a blank for the last two digits to be filled in by the broker, and deleted "For this reason, the dual agent(s) may not be able to advocate on behalf of the client with the same skill and determination the dual agent may have if the brokerage firm represents only one client." Near the bottom of the first page revised "Relationship to the Government is tenant representation bound by the terms and conditions of contract #". Revised the signature blocks.
