WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended as follows:


- A. The Government hereby accepts the Lessor's proposal to provide all labor and materials necessary to install and maintain the improvements as identified in the GSA Scope of Work (TSC-130) dated June 15, 2017 (Exhibit A) and in the CBRE Estimate dated July 27, 2017 (Exhibit B) and issues a Notice to Proceed for Tenant Improvements in the amount of \$5,900.00.
- B. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$5,900.00, upon receipt of an original invoice after completion, inspection, and acceptance of the space by the Contracting Officer.

A properly executed invoice requesting lump sum payment in the amount of \$5,900.00 must be submitted electronically to the GSA Finance Office and a copy of the invoice must be submitted to the Contracting Officer at:




