**WHEREAS**, the parties hereto desire to amend the above Lease. **To Issue Notice to Proceed for the construction of Tenant Improvements.** .

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution by the Government as follows:

- A. This Lease Amendment (LA) formally and officially issues Notice to Proceed in the amount of \$243,566.05 for the [REDACTED] [REDACTED] Tenant Improvements in accordance with the lessor's firm fixed priced proposal dated October 20, 2015. The proposal is hereby incorporated into the lease by reference.
- B. Upon completion of the work, the Lessor shall notify the Contracting Officer to arrange for an inspection. After inspection and acceptance of the work by the Government, the Tenant Improvement cost totaling \$243,566.05 which will be amortized over the firm term on the lease at an interest rate of 7%. The effective date and resulting rental rate shall be established in a future Lease Amendment.

All other terms and conditions of the lease shall remain in force and effect.
