NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon Government execution of this Lease Amendment as follows:

Upon execution of this Lease Amendment (LA) by the Contracting Officer, this LA serves as a Notice to Proceed (NTP) for the tenant improvements:

1. NOTICE TO PROCEED

This Lease Amendment serves as a Notice to Proceed for construction of Tenant Improvements in the amount of **\$310,390.64**. Of this amount, **\$173,730.55** will be amortized into the rent under the "Tenant Improvement Allowance" and pursuant to the Lease. The remaining amount of **\$136,660.09** will be paid in a one-time lump sum to the Lessor upon completion, inspection and acceptance of the work and receipt of an invoice or invoices for the work, by the Government.

Be advised that any work that is done that exceeds the costs specified above will be the financial responsibility of the Lessor. In accordance with the Lease, the Lessor shall complete all work within **one hundred twenty (120)**-calendar days of execution of this Notice to Proceed.

This Lease Amendment contains 2 page(s).

All other terms and conditions of the lease shall remain in force and effect.
