1. Paragraph 1.08 "Tenant Improvements and Pricing" is hereby amended to reflect the following:

The tenant improvement allowance (TIA) for purposes of this Lease is <u>\$229,688.55</u> per ABOA SF. The TIA is the amount that the Lessor shall make available for the Government to be used for the Tis. This amount is amortized in the rent over the firm term of this Lease at an annual interest rate of <u>6.9%</u> percent. The Government shall have the right to make lump sum payments for any or all TI work.

2. Lease Term of Lease is hereby amended to reflect the following:


