2.) The schedule for the Lessor's preparation and submission of construction documents (CDs) shall be as follows:

The Lessor as part of the TI must complete Lessor initial Construction Documents (CDs), 50%, conforming to the approved DIDs not later than **15** Working Days following the approval of DIDs. The Government shall have **10** Working Days to review CDs. The Lessor shall complete Lessor Second Development CDs, 95%, not later than **15** Working Days following the approval of 50% CDs. The Government shall have **10** Working Days to review 95% CDs. The pricing for this work is included under the A/E fees established under Section 1 of the Lease. If during the preparation of the CDs the Lessor becomes aware that any material requirement indicated in the approved DIDs cannot be reasonably achieved, the Lessor shall promptly notify GSA, and shall not proceed with completion of the CDs until direction is received from the Lease Contracting Officer (LCO). The LCO shall provide direction within **10** Working Days of such notice but the Government shall not be responsible for delays to completion of CDs occasioned by such circumstances. For the purpose of this paragraph, a "material requirement" shall mean any requirement necessary for the Government's intended use of the Space as provided for in, or reasonably inferable from, the Lease and the approved DIDs (e.g., number of workstations and required adjacencies).
