

## **Safety Performance and Flammability requirements for SIN 33712 Complete Daycare, Preschool and Classroom Solutions and SIN 33721T Training Room, Auditorium and Theater Furniture**

Your products are required to meet specific test requirements when items are offered under:

- SIN 33712 Complete Daycare, Preschool and Classroom Solutions
- SIN 33721T Training Room, Auditorium and Theater Furniture

During the contract period for the schedule, products manufactured must meet the applicable standards in effect at the time of manufacture. You can obtain copies of the referenced documents from the issuing organizations below.

### **Safety/Performance Test Requirements**

The products you offer must meet latest issue of the following safety/performance test requirements. You must provide evidence of compliance with requirements, according to the “Technical Requirements” section of the solicitation.

- **High chairs** must meet ASTM Standard F404, “Standard Consumer Safety Specification for High Chairs.”
- **Non-full-size cribs** must meet ASTM Standard F406, “Standard Consumer Safety Specification for Non-Full-Size Baby Cribs/Play Yards.”
- **Toy chests** must meet ASTM Standard F834, “Standard Consumer Safety Specification for Toy Chests.”
- **Toys** must meet ASTM Standard F963, “Standard Consumer Safety Specification for Toy Safety.”
- **Full-size cribs** must meet ASTM Standard F1169, “Standard Specification for Full Size Baby Crib.”

- **Toddler beds** must meet ASTM Standard F1821, “Standard Consumer Safety Specification for Toddler Beds.”
- **Bassinets and cradles** must meet ASTM Standard F2194, “Standard Consumer Safety Specification for Bassinets and Cradles.”
- **Folding chairs with a seat height of 15” or less** must meet ASTM F2613, “Standard Consumer Safety Specification for Children’s Folding Chairs.”
- **Rotary base chairs and stools** must meet all applicable sections of either:
  - ANSI/BIFMA X5.1, “General-Purpose Office Chairs – Tests.”
  - Business and Institutional Furniture Manufacturers Association.

### **Flammability Test Requirements**

The products you offer must meet the following flammability test requirements.

- **Vertical fabrics** used in or on any furniture items must meet flammability requirements for “Vertical fabrics” in the “Technical Requirements” section of the solicitation.
- **Mattresses/Foundations and mattress pads** must meet applicable test requirements contained in both:
  - The Code of Federal Regulations, Title 16, Part 1632, Standard for the Flammability (Cigarette Ignition Resistance) of Mattresses and Mattress Pads (FF 4-72, Amended).
  - Title 16, Part 1633, Standard for the Flammability (Open Flame) of Mattress Sets.
- All **upholstery components** (fabrics, vinyls, leathers, foams, batting, etc.) used in all seating products you offer, must comply with the applicable requirements of the [State of California Technical Bulletin \(TB\) 117](#). You must provide evidence of compliance with the Cal 117 test requirement as specified in “Flammability Test and Reporting Requirements” under “Seating” in the “Technical Requirements” section of the solicitation.
