The annual air sampling results for the North Los Angeles Federal Building (NLA) continue to indicate there are no recognized health hazards in the areas sampled at this property. The building remains safe to occupy.

AGENCY NOTIFICATIONS

Agency representative must contact GSA's Building Facility Asbestos Control Manager Myrna G. Barragan, at (213) 479-7579 or via email myrna.godinez-barragan@gsa.gov, prior to performing work in the building. Agencies must follow all required procedures and regulations when performing work in the building.

BUILDING PROCEDURES

In order to adhere to ACM requirements for the 2021 Building Operations and Maintenance Plan and to ensure the safety of building tenants, all agencies must coordinate and consult with GSA prior to performing any additional environmental testing in tenant-controlled space. However, no further testing or investigation is allowed above the ceiling anywhere in the building unless authorized by GSA, in writing.

Ceiling tiles are not to be opened, removed, or moved in any manner in order to prevent disturbing potential ACM above the ceiling. Please ensure all employees, and contractors, where applicable, are informed of this requirement.

SURVEY CONSULTING SERVICES

GSA Contractor, Titan Environmental Solutions (TES) completed the comprehensive asbestos-containing materials survey and inventory of asbestos containing materials for the purpose of developing a comprehensive Operations and Maintenance Plan, also known as the Facilities Asbestos Action Plan (FAA). The TES scope of work included an asbestos survey of the Sub Basement, Basement, Floors 1st through 8th, and the Penthouse. GSA continues to work on developing acquisition plans for remediation and or abatement services.
